**New Reader Board!** In our continued effort to better inform our residents we have planted a new Reader Board at our entrance with large type-face letters to allow easy reading at speeds of less than 25 MPH.

#### **IMPORTANT ISSUES:**

**Yard maintenance** is critical especially in a close community like Rustlewood. Plus, the fire season is now approaching. Section 7 (a) of the CC&R's spells out our responsibilities in maintaining our properties. It states:

a. Maintenance. All properties within Rustlewood, including any structures or grounds should be kept in a safe and reasonable state of repair, cleanliness and neatness. Undesirable weeds having a tendency to spread across property lines shall be kept under control. A lot or structure is deemed as poorly maintained if its condition offends the reasonable sensibilities or affects the safety of the residents of theRustlewoodcommunity. The judgment and appropriate action regarding the lot or structure will be considered by the members of the Rustlewood Association Board.

July 4<sup>th</sup>! Please remember that fireworks are only allowed on our beach at the Cabana. The beach area will be roped off to indicate where fireworks may safely be used. Only adults and supervised children 12 years or older can go past the roped off area. This program has worked very well the last couple of years so let's keep the good record of celebrating safely. After celebrating, please take all the accumulated trash up to the barrels near the boat ramp gate and stack it there. It will be picked up by volunteers and taken to the dump for proper disposal.

**25 MPH!** We continue to receive complaints about drivers not understanding what 25 MPH means. The speed limit once you enter Krabbenhoft Road from Highway 3 is posted at 25 MPH. This is very serious, folks. We have a lot of school kids and others walking on our roads so please, please be aware and considerate. If you observe a speeding violation and want to report it, get the license number and please use the non-emergency Sheriff number: 360-426-4441.

**BOAT LAUNCH:** Launch, pull out and park and lock! It's that simple. First, there is no room to park your car and trailer on or near the boat ramp. It becomes a safety hazard if there is a need for emergency vehicles or if another member wishes to launch their boat. So, please after the boat launching, remove your vehicle and trailer and park outside the gate. Then, lock the gate.

**RENTING?:** All homeowners who rent their properties must comply with the Association By-Laws regarding notification of the renter's names and contact information annually whether they are long-term renters or new. See: Rustlewood Association Bylaws, Article I: Membership, Section 2. Information is due by October 1st of each year. Failure to comply may result in a fine.
