If you rent your properties and have not yet reported as required please submit the attached form by July 1 and it will be considered late by October 1 at which time a fine may be assessed. This is a yearly requirement and a form will be mailed annually along with notice of the association annual meeting and yearly dues. This form will also be available on our website:

The rental occupant list is important to fire, medical and law enforcement personnel to provide support in case of an emergency. The rental occupant list is beneficial to the Board of Rustlewood to invite the occupants to use the Rustlewood facilities and participate in any Rustlewood activities. The use of Rustlewood facilities must be approved by you the owner of said property as outlined in Article 1: Membership Section 2.

Rustlewood Association By-Laws state:

### **Article 1: Membership Section 2:**

Any owner, who rents one (1) or more lots to others, shall advise the secretary, in writing, of the tenant's name, address, and telephone number, as well as when each tenancy commences and ceases. The owner, as well as the tenant, shall be responsible for any violation of a Rustlewood Restrictive Covenant by such tenant.
